QUESTION ONE

Answer “Yes” or “No” to the following questions.

- A) While the play of a hand is in progress, may Dummy ask an opponent if he has revoked?
- B) Must players look at the face of their cards before making their first call?
- C) May a player consult with partner before choosing from a number of options available to her after an opponent’s infringement?

- D) May Dummy call the director if attention has already been drawn to an infringement?
- E) Is an agreement to include 7222 shaped hands in a 12-14 HCP 1NT opening permitted as part of a Blue System?
- F) A player realizes he revoked several tricks back. Is he required to draw attention to this accidental infringement?
- G) Is whether or not the pencil has left the bidding slip relevant in deciding whether a call is inadvertent?
- H) May a player deviate from his agreed system in the hope of misleading the opponents? (NB: There is no prior agreement to do so.)
- I) If declarer tells Dummy to “play anything”, may either defender name a card to be played from the dummy?
- J) Your partner gave a wrong explanation during the auction. Must you announce this before you make the opening lead?
- K) Part way through the play of a hand, declarer claims the remaining tricks. Must the hand be played out if either defender so requests?
- L) During the auction West withdraws a call that shows spades and another unspecified suit. May the eventual declarer North prohibit the opening lead of a diamond?
- M) May an insufficient bid be replaced with a double?
- N) East has a major penalty card. West is on lead and also has a major penalty. Must West lead his major penalty card?
- O) Must a natural jump overcall be alerted if it shows 11+ HCP?
- P) Should dummy turn over or otherwise conceal the bidding slip after third hand has played a card to the first trick?
